IN ORDER TO BETTER EQUIP SURVIVORS WITH THE SKILLS NECESSARY TO MAINTAIN LIVES FREE FROM VIOLENCE, WE PROVIDE COMPREHENSIVE IN-HOUSE SERVICES INCLUDING INDIVIDUALIZED SUPPORT GROUPS, LIFE-SKILLS CLASSES, PARENTING CLASSES, CHILDREN'S PROGRAMS, A 50-HOUR WEEK FREE CHILDREN PROGRAM, PERSONAL ADVOCACY AND REFERRALS FOR OUTSIDE SERVICES. WE ALSO OPERATE A 24-HOUR, CRISIS HOTLINE THAT PROVIDES CRISIS INTERVENTION, DOMESTIC VIOLENCE EDUCATION, NON-JUDGMENTAL, CONFIDENTIAL SUPPORT, AS WELL AS RESOURCE AND REFERRAL SERVICES. SVS HAS TWO PERMANENT LOCATIONS IN WEST JORDAN AND RIVERTON AND SATELLITE LOCATIONS AT SIX PUBLIC LIBRARIES AND THE ROAD HOME'S MIDVALE SHELTER LOCATION.
