Shelter Services

Shelter Services provide a temporary safe home for survivors of domestic violence and their families. South Valley Services shelter has 13 rooms and 56 beds. Including one temporary room with one couch and two queen size beds. Each family has their own bedroom with a private bathroom. There are communal areas such as the living room, teen room, computer room, laundry room, kitchen Children's Learning Center, and playground. In fiscal year 2021/22 South Valley Services provided shelter for 510 individuals of which 42% percent were children. Additionally, the Shelter answered 4,276 crisis hotline calls of which 1,987 were high risk of homicide.

South Valley Services has multiple Community Resource Center locations in the cities of West Jordan, Riverton, Kearns, West Valley and Salt Lake City. The Community Resource Centers can assist individuals with finding the appropriate resources to meet their needs and achieve their goals. By utilizing a coordinated community response model, we are able to offer case management services to all community members in the areas of family violence, community resources, mental health, etc. We also offer housing services to victims of domestic violence through our Housing Program. In fiscal year 2021/2022, South Valley Services provided 6,702 case management services to 990 clients experiencing domestic violence and/or sexual assault. We also provided 1797 hours of clinical counseling provided by 8 clinicians for 474 survivors.
