Shelter Services provide a temporary safe home for survivors of domestic violence and their families. South Valley Services shelter has 13 rooms and 56 beds. Including one temporary room with one couch and two queen size beds. Each family has their own bedroom with a private bathroom. There are communal areas such as the living room, teen room, computer room, laundry room, kitchen Children's Learning Center, and playground. In fiscal year 2022/23 the West Jordan site provided 14,160 nights of shelter for 455 individuals of which 42% percent were children. Additionally, West Jordan answered 3,583 crisis hotline calls of which 1,030 were high risk of homicide. The Tooele site provided 3,427 nights of shelter for 94 individuals of which 37% were children. Additionally, the Tooele site answered 3,427 crisis hotline calls.

Healthy Relationship classes are a critical part of South Valley Service's mission to prevent domestic violence. By attending Healthy Relationship classes, participants will learn how to identify healthy relationships and build skills to improve the relationships in their lives. In fiscal year 2022/2023, South Valley Services provided education at 240 events to 5305 recipients.
