Shelter Services

Shelter Services provide a temporary safe home for survivors of domestic violence and their families. South Valley Services shelter has 13 rooms and 57 beds. Each family has their own bedroom with a private bathroom. There are communal areas such as the living room, laundry room kitchen and playground. In fiscal year 2019/20, South Valley Services provided shelter for 460 individuals of which 45.43% percent were children. Additionally, the Shelter answered 4,564 crisis hotline calls of which 1,369 were high risk of homicide.
