Updates from Salt Lake County

Our Education and Prevention Director revitalized the Financial Empowerment Program (FEP), which transitioned to a virtual format during COVID-19. Recognizing the importance of in-person learning, we brought the program back to our shelter and resource center. Financial education plays a crucial role in helping survivors of domestic violence regain control of their lives. By offering modules on financial abuse, budgeting, credit basics, loans, and savings/investment, this program equips survivors with the skills they need to rebuild their financial independence and create a stable future for themselves and their families.

Now that FEP is back in person, we're excited to watch this program grow and continue empowering survivors. The value of financial knowledge not only supports their immediate needs but also strengthens their long-term resilience. By fostering a safe and supportive environment, we aim to encourage open discussions about finances, breaking down the barriers that often hold survivors back. As participants engage in hands-on learning and share their experiences, we believe they will build confidence in managing their finances and making informed decisions.

Updates from Tooele County

Since opening our Survivor Advocacy Center in December 2023, we've established a welcoming space for Community Support Groups, providing essential resources for those impacted by domestic violence and sexual assault. Held every Tuesday, these sessions offer a supportive, judgment-free environment where individuals can connect, share experiences, and heal together. Our groups aim to reduce the isolation that survivors often feel, creating a safe space to discuss trauma's effects. Each meeting utilizes the Seeking Safety curriculum, offering practical tools for managing trauma and stress. Members find the curriculum relatable and empowering, engaging actively to voice frustrations and navigate personal challenges.

Beyond individual growth, the groups foster a strong sense of empowerment and connection. Many participants express relief in knowing they're not alone, finding strength in shared experiences and mutual encouragement. The camaraderie within these sessions often leads to lasting bonds, forming a supportive network that extends beyond weekly meetings. We're inspired by the growth and resilience we've witnessed and are grateful to have the Advocacy Center as a dedicated space for this vital support.

Some volunteers used their skills to enhance our spaces and services with yard work, assembling furniture, organizing resources, and preparing for seasonal activities like summer camp. Their efforts helped to create a supportive and functional environment for survivors and their families.



SVS realized a positive Change in Net Assets due to revenue recognized in FY 2024 that reimbursed SVS for fixed assets capitalized on the Statement of Financial Position. These fixed assets will be depreciated over their useful life.

Looking Ahead

As we reflect on the incredible progress South Valley Services has achieved over the past few years, we are inspired by what is yet to come. Looking ahead, we know we can't settle with our current capacity. We must expand our ability to serve the unmet needs of our community through increasing bed space, housing, specialized clinical services, and ongoing supportive advocacy and case management. We have some work to do, and we need your support.

Today, we continue to face the difficult challenge of turning away survivors' requests for shelter services when our beds are full, while our staff works tirelessly to minimize the wait list for counseling services. Meanwhile, the need for community awareness and prevention education efforts has not diminished.

Our goal for the coming year is to increase the quality and capacity of services provided at our shelters and community advocacy centers. To achieve this, we will add additional groups and classes; we are committed to expanding our educational reach across Salt Lake and Tooele Counties to raise awareness and financial support for these critical life-saving services; and we are preparing to increase bed capacity with transitional housing to better support those in need.

We ask you to please look for ways you can support us in these efforts. Volunteer. Donate.
